l.	Welcome Bruce Bowman
	Bruce Bowman, Chairman, called the meeting to order. It was established that a quorum was present.
11.	Consent Agenda Bruce Bowman
	Mr. Bowman informed those present that a Consent Agenda (consisting of Minutes from the previous WIB and CCEO meetings, Performance Reports, and Dislocation Reports) had been mailed for review. Mike Babb made the motion that the Consent Agenda be accepted. Dan Penland seconded. Motion carried unanimously.

IV.	Governor's Office of Workforce Development Tricia Pridemore
	Tricia Pridemore, Executive Director, Governor's Office of Workforce Development, provided a presentation regarding current and future initiatives.
V.	Youth Council Report and Recommendations
	Angie Douglass presented the "Northwest Georgia Workforce Program Youth Council Youth Providers Performance" Report (attached). The Youth Council approved the report and recommends WIB/CCEO

approval. Angie Douglass made the motion to approve. Shelia Callaway seconded. Motion carried unanimously.

Ms. Douglass also informed those present that the Youth Council discussed strategies to meet the 20% requirement in serving 15, 15, and 16 year olds and will make recommendations as needed.

VI. Proposal Review Committee Report & Recommendations ...... Dan Penland

Dan Penland reported that Chattahoochee Technical College Continuing Education submitted a proposal for Wastewater System Operator Class III and Water Distribution System Operator Class III. Although these provide well paying jobs, a previous attempt at another school yielded only one job among eight students. Also, an internet search was done for job openings and only one job (in the Atlanta area) was found, with the rest being around the country. A local municipality informed staff that turnover in this field is extremely low. The Proposal Review Committee recommended tabling this request pending information that there is sufficient demand for these jobs in our area. Mike Babb made the motion that this recommendation be accepted. Lynne Reese seconded. Motion carried unanimously.

Mr. Penland informed those present that Georgia Northwestern Technical College has made changes to the Certified Logistics Entry Level and Mid Level courses. The new instructor has determined that the courses can be designed to last for a shorter time span and at a lower cost. Participants will still be in programs recognized by the American National Standards Institute and receive forklift training and be able to earn a certified OSHA operator card. This was designed to assist people to work at the new Lowe's distribution center and other related occupations. The original program(s) have already been approved. The Proposal Review Committee approved this request and recommends WIB/CCEO approval. Jerry Garland made the motion to approve. Lorain Green seconded. Motion carried unanimously.

Mr. Penland then report that one participant was in the NEG disaster work experience in Dade County. He is attending Bryan College taking Business Administration. The school returned their application to be a WIA provider to our office on September 18, 2012. He stated that we could possibly help him finish the rest of his course, using NEG disaster funding, as a pick up, not to exceed our limit of \$6,500. The Proposal Review Committee approved this request. Mike Babb made the motion to approve. Loraine Green seconded. Motion carried unanimously.

Mr. Garland stated that the Planning Committee met but did not have a quorum. He asked Gwen Dellinger to present the changes to the Plan. Jerry Garland made the motion to approve. Jim Henry seconded. Motion carried unanimously.

VIII. Consortia Report and Recommendations ....... Jerry Garland

Mr. Garland reported that the USDOL recently recommended that NWGRC utilize an Occupational Skills Assessment system. Staff released a Request for Proposal and received one response. The response did not include signatures on the required forms. The Consortia approved *Prove It!* by Kenexa at a cost of \$24,250 for 21 subscriptions, contingent upon the signed forms being received and recommends WIB/CCEO approval. Angie Douglass asked if participants would get a report after completing the assessment. Tammy Helbing answered that they would. Mr. Garland noted that this is a skills assessment, not an interest assessment. Mike Babb asked if the 21 subscriptions included multiple uses at

each location. Ms. Helbing answered that it did provided for multiple uses for each subscription. Jerry Garland made the motion to approve. Shelia Callaway seconded. Motion carried unanimously.

IX. Employer Committee Conference Report ...... Loraine Green

Loraine Green presented information from the Employer Committee Conference.

X. Change in November Meeting Date ..... Bruce Bowman

Mr. Bowman informed those present that the regular date for the November meeting will fall on the day before Thanksgiving. He suggested that the meeting date be moved to November 14, 2012 with the time and place remaining the same. Loraine Green made the motion that this change in meeting date be approved. Jerry Garland seconded. Motion carried unanimously.
