I. Welcome Ted Rumley

Ted Rumley, Chairman of the Council of Chief Elected Officials called the meeting to order and welcomed those present. It was established that a quorum was present for the Council of Chief Elected Officials.

II. Consent Agenda Ted Rumley

This report encompasses the Adult, Dislocated Worker, COVID/Disaster, HDCl, and Youth programs. Mr. Rumley asked if money could be moved from one funding stream to another. Mr. Rucker replied that funds can be moved from Dislocated Worker to Adult but not vice versa. Steve Taylor made the motion that the CCEO accept the report. Shannon Whitfield seconded. Motion carried unanimously.

IV. Workforce Development Board Membership Terri Morgan

Terri Morgan informed those present that a nomination had been received from Jason Mock, President and CEO, Greater Dalton Chamber, for Terry Craft, Co-Founder and CEO, Your S.A.F.E Consultants and Training, LLC.
