I. Welcome..... Mike Schwaderer/Ted Rumley/Angie Robinson

In the absence of Bruce Bowman, Chairman, Mike Schwaderer, Vice-Chairman, called the meeting to order. It was established that a quorum was present. Mr. Schwaderer asked Ted Rumley, Chairman of the Council of Chief Elected Officials, and Angie Robinson, Vice-Chairman of the Youth Council, how they wished to proceed with the meeting. Mr. Rumley and Ms. Robinson stated that they wished to proceed with a joint meeting.

Mr. Bowman informed those present that a Consent Agenda (consisting of Minutes from the previous WIB and CCEO meetings, Performance Report, Dislocation Report, The Conference Board Report, and Regional Job Analysis by County) was attached and had been mailed for review. Ted Rumley made the motion that the Consent Agenda be approved. Rick Goble seconded. Motion carried unanimously.

Angie Robinson presented the Youth Council minutes (attached) to the Youth Council members present. She noted that "Ms. Douglas" should be changed to "Ms. Robinson" in the first paragraph. Curtis Kingsley made the motion to accept the minutes with the noted correction. Paul Ray seconded. Motion carried unanimously.

Ms. Robinson also presented the Credential Attainment Policy (attached). A change was made reflecting "contracted hours" instead of the previous stipulation of 480 hours. Curtis Kingsley made the motion to accept this change to the policy. Eric Waters seconded. Motion carried unanimously.

David Guldenschuh informed those present that RS Thomas Training Associates of Atlanta, currently a state approved provider, submitted a proposal for a Financial Management Professional, which includes training for Georgia Department of Insurance license for (1) Claims Adjuster, (2) Life, Accident, & Sickness Agent, and (3) Property and Casualty Agent. This is a 12 week, 120 classroom-hour course with a total cost of \$1,953 (handout attached).

Students may also take one component for a total of two weeks and 40 classroom hours for a fee of \$798. Mr. Guldenschuh stated that the Proposal Review Committee had approved this training. Lance McCravy made the motion to approve. Mitchell Morgan seconded. Motion carried unanimously.

Gwen Dellinger informed those present that an additional approximately \$81,000 in dislocated worker funding had been made available for use in our area.

Ms. Dellinger stated that staff requested that the following policies be approved:

- A. Work Experience Policies-Adult and Dislocated Workers (attached). Loraine Green made the motion that this policy be approved. Mitchell Morgan seconded. Motion carried unanimously.
- B. Internship Policy-Adults and Dislocated Workers (attached). David Guldenschuh made the motion that this policy be approved. Mitchell Morgan seconded. Motion carried unanimously.
- C. Credential Attainment Policy (attached). Shelia Callaway made the motion that this policy be approved. Beth Kelley seconded. Motion carried unanimously.
